SUMMARY OF MINUTES OF THE 2024 ANNUAL GENERAL MEMBERSHIP MEETING

18 May 2024 – 2:30 P.M. – Video Conference

I. Call to Order

GEN ROMEO S BRAWNER JR PA, Chairman of AFPMBAI, presided over the meeting and called the meeting to order at 2:30 P.M.

II. Proof of Due Notice of the Meeting

The Corporate Secretary, Atty Jonas B Calleja, attested that the Notice for the Annual General Membership Meeting (AGM) was duly published in the Manila Bulletin and in the People's Journal on April 13, 2024, with an addendum published on April 27, 2024 changing the time of the meeting to 2:30 PM. He stated that the Notice and Agenda, and downloadable Proxy Form, was also uploaded on the AFPMBAI website on April 12, 2024, thus AFPMBAI has complied with the required notices pursuant to Art V, Sec 3 of the Bylaws.

III. Proof of Presence of Ouorum

Atty Calleja reported that there were 184 registered regular members virtually present and 759 registered members who voted in absentia, composing the quorum. IV. Opening Remarks

GEN ROMEO S BRAWNER JR PA, Chairman of AFPMBAI, welcomed everyone to the 2024 AGM and thanked them for their trust in the Association. He gave an overview of the performance of AFPMBAI in 2023, particularly in the areas of strategic development and expansion, governance and financial growth, social impact and community engagement, innovative services and member engagement, as well as digital transformation and customer service. He called on each one to work together to secure a "Panatag na Buhay" for the members of AFPMBAI.

V. Approval of the Minutes of the Annual General Membership Meeting dated 20 May 2023

VII. Report of the President and CEO

The President and CEO, BGen Bienvenido Y Regondola PA (Ret), reported on the performance of AFPMBAI for CY 2023 covering its strategic objectives under the Balanced Scorecard: Social Impact, Financial Perspective, Customer Perspective, Internal Process Perspective, and Learning and Growth Perspective. As a way forward, he stated that the needs of members will always come first in AFPMBAI.

After President Regondola rendered his report, SMS Jeanly Bediones PA inquired if he could still be covered by basic insurance or MBAI Protek after he retires from the active service. President Regondola replied, stating that after he retires from the active service, his MBAI Protek coverage will end and he will receive 50% of his total insurance premiums or equity contributions, including interest, as his termination benefit. He may still continue his membership with AFPMBAI even after retirement by availing the MBAI iProtek product at P499 monthly premium for Enlisted Men (or P999 premium for Officers). President Regondola encouraged everyone to continue with their AFPMBAI membership even after they leave the active service, so that they will continue to be covered with insurance until 70 years of age.

IX. The Audit Committee Annual Report for CY 2023

He further reported that the statutory audit of the Association's 2023 Financial Statements was completed as scheduled and was presented to the Board of Trustees on 08 April 2024 with Unqualified Opinion. An unqualified opinion means that the AFPMBAI's financial statements are fairly and appropriately presented, without any identified exceptions, and in compliance with generally accepted accounting principles.

X. Report of the Governance Committee

Gen Ricardo A David Jr PA (Ret), Chairman of the Governance Committee, reported on the efforts the Committee initiated in 2023 to improve the governance practices of the Association, which included the institution of the conduct of External Assessment of Board Performance every three years, the performance assessment of Chief Risk Officer (CRO) and the Chief Compliance Officer (CCO), as well as the restructuring of Board committees to assure a majority of independent trustees in the Governance Committee and the Audit Committee. Further, Gen David reported that, in compliance with Insurance Commission Circular Letter No. 2020-71 on the Revised Code of Corporate Governance for Insurance Commission (IC) Regulated Companies, the Board also elected its Lead Independent Trustee in 2023. And for the first quarter of 2024, through the initiative of the Governance Committee, the Board included in its Manual of Corporate Governance the rights that AFPMBAI has always upheld for its members. These rights were enumerated as follows:

- 1. The right to be provided excellent products and services.
- 2. The right to be informed.
- 3. The right to participate.
- 4. The right to nominate.
- 5. The right to vote.
- 6. The right to be heard.
- 7. The right to receive feedback.
- 8. The right to be involved.

He also stated that the more comprehensive report of the Governance Committee can be found in the Governance Report for CY 2023, published in the AFPMBAI Website.

XIII. Board Per Diem and Allowances

A. Study of the Institute of Corporate Directors on Board Per Diem and Allowances

In a video presentation, Mr Rex Drilon II, fellow of the Institute of Corporate Directors (ICD), reported to the body the results of the study they made on benchmarking the per diem and allowances of AFPMBAI's Board members with that of publicly-listed corporations (PLCs), and with companies within the Association's own industry. The result of their findings were summarized as follows:

- Currently AFPMBAI is at 10th-25th percentile and below average (ranges: 10th, 25th, 50th, 75th, 90th) among the PLCs;
- Compared to Life Insurance Companies, AFPMBAI also appears to be below average;
- Compared to other Mutual Benefit Associations, it is way above the numbers; and,
- Because of AFPMBAI's track record and industry position, the review of Board per diem and allowances and possible adjustments moving forward is in order.

- B. On "How would you evaluate the overall performance of the AFPMBAI Board of Trustees, composed of active and retired military and uniformed personnel from the different branches of service, in terms of fulfilling the strategic thrust for Member Satisfaction?", the Board received an average rating of 95.23% or Outstanding.
- C. On "How would you evaluate the overall performance of the AFPMBAI Board of Trustees, composed of active and retired military and uniformed personnel from the different branches of service, in terms of fulfilling the strategic thrust for Digital Transformation?", the Board received an average rating of 95.14% or Outstanding.
- D. On "Do you believe that AFPMBAI, through the direction of its Board of Trustees, has so far accomplished its Mission to "provide members and their families with comprehensive insurance, opportunity for lifetime security, and significant social services?", the Board received an average rating of 95.58%, or Outstanding.

Thereafter, upon motion of SSgt Mary James B Camarillo PAF, duly seconded by SMS Oliver S Engallado PAF, the body noted the result of the survey on Board performance.

The CHAIRMAN also recognized the accomplishments and dedication of the outgoing Trustees during their term.
