**AMENDED ARTICLES OF INCORPORATION
OF THE ARMED FORCES AND POLICE
MUTUAL BENEFIT ASSOCIATION, INCORPORATED (AFPMBAI)
(Formerly: ARMED FORCES AND POLICE MUTUAL BENEFIT
ASSOCIATION, INCORPORATED)**

KNOW ALL MEN BY THESE PRESENTS

That we, all of whom are of legal age, residents and citizens of the Philippines, have this day voluntarily associated together for the purpose of forming an association under the laws of the Philippines.

AND WE HEREBY CERTIFY:

FIRST: That the name of said corporation shall be the ARMED FORCES AND POLICE MUTUAL BENEFIT ASSOCIATION, INCORPORATED (AFPMBAI), hereinafter referred to as the Association.

SECOND: That the purposes of which this Association is formed are:

- a. To foster brotherhood and mutual help and benefit among the members;
- b. To encourage the habit of thrift and saving among the members of the society;
- c. To provide financial or material assistance to members and their families in case of death, losses, necessities, or distress, as may be authorized under the Revised Administrative Code and pertinent rules and regulations issued by the Insurance Commissioner;
- d. To promote the general welfare of the members and their families;
- e. To perform welfare services vital to the morale of its members;
- f. To hold funds in trust for the members of the Association;
- g. To provide life and accident insurance, housing and other similar services to members and their families; and
- h. In general, to do such acts and undertake such activities not otherwise prohibited by law to help the members and to accomplish the purposes for which the Association has been organized.

INCIDENTALLY:

- i. To acquire real or personal property necessary for its operations;
- j. To issue membership certificates;
- k. To make donations pursuant to its corporate social responsibility initiatives; and (As amended on 17 May 2025)
- l. To possess and enjoy all the powers and privileges under the laws of the Republic of the Philippines for the attainment of the above purposes of the association; Provided, however, That the funds of the Association shall not be spent except in accordance with law and as approved by the Board of Trustees thereof. (As amended on 17 May 2025)

The primary purpose for which the Association was created falls under Section 30 (C) of the National Internal Revenue Code of 1997, as amended: "A beneficiary society, order or association, operating for the exclusive benefit of the members such as a

fraternal organization operating under the lodge system, or mutual aid association or a nonstock corporation organized by employees providing for the payment of life, sickness, accident, or other benefits exclusively to the members of such society, order, or association, or nonstock corporation or their dependents;”.

THIRD: That the place where the principal office of the Association is to be established or located is at AFPMBAI Building, Col Bonny Serrano Road corner Epifanio delos Santos Avenue, Quezon City.

FOURTH: That the term for which said Association is to exist has been extended for another fifty (50) years starting on 13 January 2016.

JANTE has been elected as Treasurer of the Association by the members to act as such until a successor shall have been duly elected and qualified in accordance with the By-Laws, and that as such Treasurer, he has been authorized to receive for the Association and to issue receipt in the name of the Association for contributions paid by such members.

NINTH: That no part of the Association's net income shall inure to the benefit of any private individual.

TENTH: The trustees of AFPMBAI receive no compensation or remuneration except for reasonable allowance and per diems.

ELEVENTH: In the event of dissolution, the existing assets of the Association will be passed on to another accredited NGO or organization of similar thrusts or purpose/s or to the State for public use.
